Page 60 (updated April 18, 2024)

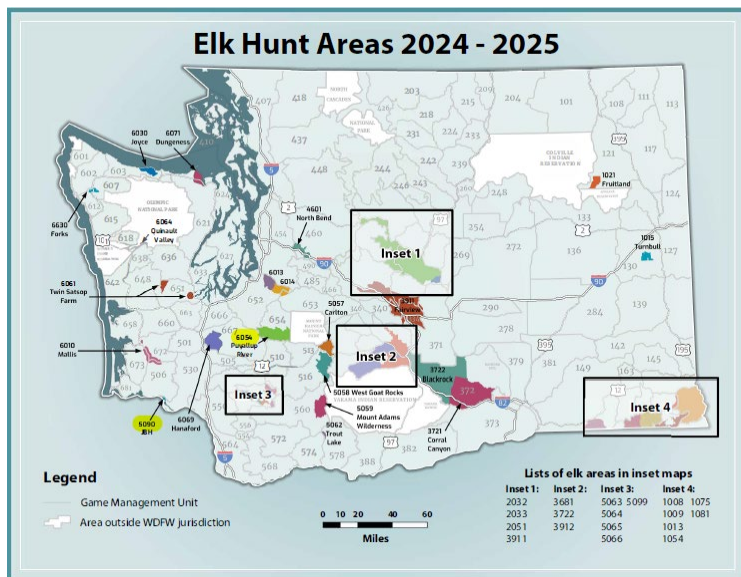
The hunt dates for hunts 2512 and 2513 have been updated to reflect the WAC: Sept. 28 – Oct. 11.

The Washington Department of Fish and Wildlife (WDFW) has extended the special hunt permit application deadline one week, until midnight May 22, 2024. WDFW made this change to allow hunters more time to complete their applications using printed copies of the 2024 Big Game Hunting Seasons and Regulations pamphlet.

Special Hunt Application deadline has changed for deer (page 24), elk (page 51), moose (page 70), Mountain goat (page 73), Bighorn sheep (page 75), and turkey (page 79) from May 15 to midnight on **May 22**.

The dates for the Rocky Mountain Sheep raffle are incorrect.

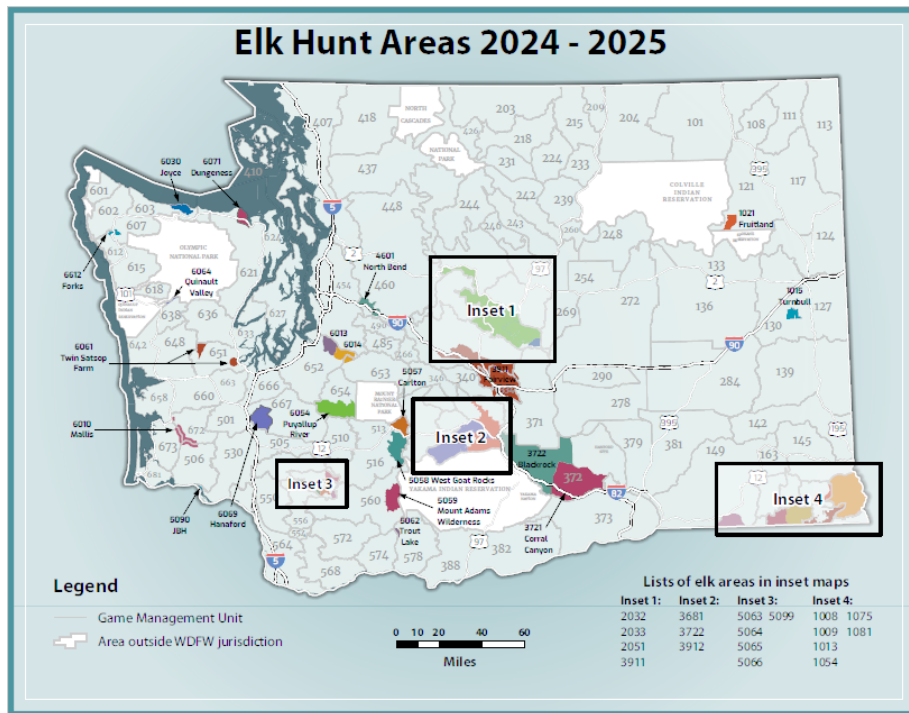
